The average taxable value of a residence homestead in City of Richardson last year was \$182,115. Based on last year's tax rate of \$0.63516 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$1,156.72.

The average taxable value of a residence homestead in City of Richardson this year is \$180,721. If the governing body adopts the effective tax rate for this year of \$0.63291 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$1,143.80.

If the governing body adopts the proposed tax rate of \$0.63516 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$1,147.87.
