Applicable Ordinance

Chapter 18, Article III, Section 18-96

- (23) Pole Signs
 - (d) Location:
 - (3) Pole signs must be located a minimum of <u>60 feet</u> from any attached building sign.


Requested Variance

• Permit a pole sign to be located 45' from an attached building sign.

Reason for request

• Due to the size of the lot and location of the building a pole sign cannot be constructed to comply with the 60' setback.












Proposed Pole Sign

- 60 sq. ft.
- 20' in height
- 45' from attached sign
- 100% digital display
- Located 4' north of current sign
- Pole with be clad in black aluminum






















Property Crime Rates per 100,000








Maintaining "Recognition" status

- Agencies prove ongoing compliance of Best Practices thru annual reports for three years following the date of recognition.
- Every four years, agencies are required to "Re-recognize" by proving again to independent assessors that the agency meets or exceeds all compliance standards during an on-site inspection process.

General

- Compliance with requirements for operator and vendors
- Health Department administer ordinance
- Farmers market operator responsible for the operation, conduct and safety of the market
- Council can establish permit fees

Application


Operator shall make application at least 14 days prior to the scheduled start of the market.

Application includes:

- Name and address of operator
- Location of market
- Description of the market (dates, hours, list of vendors)
- Site plan, with proposed structures, tents, barricades, signs, traffic plan, etc.
- Proposed signage
- Solid and liquid waste disposal plans

Location/Land Use

- Special use permit
 - Appropriate location on case by case basis OR
 - Restrict use to retail and/or commercially zoned districts
 - Impact on neighborhoods and traffic
 - Adequate parking
- Not within 1 mile of another permitted market with same or overlapping operation times
- Not in any other location other than one listed in application



Operation – Market Operator

- May not operate more than 52 days in a calendar year.
- Between hours of 8:00 a.m.-7:00 p.m.
- No more than 50 vendors
- 25% of parking area when main use of property is open for business
- Removal of all litter and belongings at end of each day
- Market operator or designee shall be present and responsible for operation

Operation – Market Operator

Allowable items

- Produce, honey, eggs, nuts, herbs, meats, mushrooms, dairy, prepared foods, arts and crafts, live plants
- Non food vendors shall not exceed 30% of vendors
- No animals sold or adopted
- No concessions
- Operator shall maintain list of all vendors for 90 days

Operation - Vendor

- Make application and pay permit fee if required
- Food Handler Course if selling Potentially Hazardous Food (PHF)
- Comply with food safety and signage regulations

Food Safety

- Food display except of plants, nuts in shell, whole or raw produce, food shall be protected from contamination from the environment, vendors, or patrons
- Approved source only food from approved source as defined by Texas Food Establishment Rules or State of Texas Cottage Food Industry rules
- Prohibited items Fish, foraged foods, game animals, gleaned foods, non pasteurized dairy items
- Sampling offered as individual servings using proper time and temperature controls and having with access to hand sink

Food Safety

- Temperature Requirements provide adequate refrigeration to keep foods frozen or refrigerated.
- Tables and utensils shall be nonporous.
- Sampling from disposable utensils only
- If sampling, vendor to have hand wash facilities
- Appropriate trash receptacles
- Vendor located on concrete or other improved surface
- Vending area to be covered unless selling plants, nuts in the shell or raw produce

Signage

- Individual vendor signs not permitted on frontage
- One farmers market sponsor sign of 32 sq. ft. maximum on each frontage of the market
- Any sign shall be 10 ft. set back from curb
- No sign be attached to building or structure
- No signs attached to people

Fee Structure Tiered Annual Permit

- Non food vendors permitted no fee
- Food vendors non potentially hazardous foods
 (PHF) permitted no fee
- Food vendors with PHF but no sampling \$50
- Food vendors with PHF and sampling \$100

Brief History of the City of Richardson Aquatic Division of Parks and Recreation

Richardson currently operates 5 outdoor pools:

- Terrace built in 1959 as a neighborhood facility- The City took ownership in 1968
- Cottonwood Pool- built in 1966
- Canyon Creek Pool- built in 1970
- Glenville Pool- built in 1974
- Heights Family Aquatic Center built in 2013

(Formerly Arapaho Pool- built in 1961)



Cottonwood Pool- 2013 Season

- Cottonwood regular operating hours in 2013 were from 1:00-6:00 pm Mondays, Wednesdays, Thursdays, and Fridays with swim lessons before and after operating hours.
- Saturdays and Sundays, Cottonwood Pool was open from 1:00-8:00 pm with swim meets and private reservations before and after public hours.
- Cottonwood Pool was open for a 71-day season in 2013.
- Home of the COR Swim team.
- Average weekly attendance 366 patrons.





Terrace Pool- 2013 Season

- Terrace regular operating hours in 2013 were from 9:00 am 5:00 pm Tuesdays, Wednesdays, Thursdays, and Fridays with swim lessons after regular hours.
- Saturdays and Sundays, Terrace was open from 1:00 8:00pm with private reservations available before and after regular hours.
- Terrace Pool has a zero-depth entry feature, and is popular for families with children ages 3 and under.
- Weekly average attendance, 438 patrons







Glenville Pool- 2013 Season

- Glenville Pool regular operating hours for 2013 were from 1:00 8:00 pm Tuesday through Sunday with swim lessons and swim team in the morning before regular hours on week days and private reservations available on Saturdays and Sundays before and after hours.
- Glenville Pool has a high volume of season pass sales.
- Average weekly attendance, 605 patrons.





Canyon Creek- 2013 Season

- Canyon Creek regular operating hours were from 1:00 8:00pm Tuesday through Sunday with swim lessons and swim team in the morning before regular hours on week days and private reservations available on Saturdays and Sundays before and after hours.
- Canyon Creek sees a high volume of season pass sales.
- Average weekly attendance, 724 patrons.







Heights Family Aquatic Center-2013 Season

- In 2013 Heights Family Aquatic Center regular operating hours were 7 days/week from 12:00 noon 9:00 pm (open 6 weeks)
- Please note: This was a learning season for the staff.
- Many aspects of the new aquatics center were studied to gain knowledge of the impact of the new aquatics format in the Richardson community.
- Average weekly attendance, 4086 patrons.







2014 Aquatic Season

- Mission is to balance aquatic assets:
 - Safety
 - Staffing
 - Facility programs
- Each year, staff reviews effectiveness of the previous year of the aquatics division for:
 - Budget preparation
 - Publications and marketing
 - Staff hiring



Proposed changes to aquatic offerings for the 2014 Season

- Conduct all swim lessons in the following pools:
 - Canyon Creek, Cottonwood, Glenville, and Terrace Pools
- Operate Heights Family Aquatics Center as a leisure pool only
 - Move swim lessons to other four pools
 - Open Aquatic Center two hours earlier each day at 10:00AM, Monday- Friday
- Allow exclusive reservations after hours at all 5 pools
- Also, allow exclusive reservations at the Heights Family Aquatic Center from 9:30-11:30AM on Saturday's and Sundays:
 - Based on Park and Recreation Commission input, increase cost of reservation from \$150 to \$300 for up to 100 person party and an additional \$25 per 25 additional participants.
 - Maximum occupancy is 600.

Next Steps

- Confirmation tonight can initiate direction for staff to provide orderly preparation of the 2014 season
 - Keep the same 12 weeks (91 days) season for all five pools as in previous year, however, if staff is available, extend the season into the "dead week" prior to school starting.
 - Program swim lessons at the existing four pools only; and
 - Open Heights Family Aquatic Center two hours earlier as a leisure pool only.
 - Season opens May 24, 2014, at Heights Family Aquatic Center only.
 - Splash day will be at all pools May 31, 2014.
