AN ORDINANCE OF THE CITY OF RICHARDSON, TEXAS, AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF THE CITY OF RICHARDSON, TEXAS, AS HERETOFORE AMENDED, SO AS TO GRANT A SPECIAL PERMIT FOR A VETERINARY OFFICE IN AN LR-M(2) DISTRICT LOCATED AT 1332 S. PLANO ROAD IN THE BUCKINGHAM PLACE SHOPPING CENTER ON A 13.437 ACRE TRACT AS DESCRIBED IN EXHIBIT "A" ATTACHED HERETO; PROVIDING A REPEALING CLAUSE; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND (\$2,000.00) DOLLARS FOR EACH OFFENSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Planning Commission of the City of Richardson and the governing body of the City of Richardson in compliance with the laws of the State of Texas and the ordinances of the City of Richardson, have given requisite notice by publication and otherwise, and after holding due hearings and affording a full and fair hearing to all property owners generally and to all persons interested and situated in the affected area and in the vicinity thereof, and in the exercise of its legislative discretion have concluded that the Comprehensive Zoning Ordinance should be amended; NOW, THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RICHARDSON, TEXAS:

- **SECTION 1.** That the Comprehensive Zoning Ordinance of the City of Richardson, Texas, duly passed by the governing body of the City of Richardson on the 5th day of June, 1956, as heretofore amended, be, and the same is hereby, amended so as to grant a special permit for a veterinary office in an LR-M(2) District located at 1332 S. Plano Road in the Buckingham Place Shopping Center on a 13.437 acre tract as described in Exhibit "A" attached hereto.
- **SECTION 2.** That the above described tract shall be used only in the manner and for the purposes provided for by the Comprehensive Zoning Ordinance of the City of Richardson, as heretofore amended.
- **SECTION 3.** That all provisions of the ordinances of the City of Richardson in conflict with the provisions of this ordinance be, and the same are hereby, repealed, and all other provisions of the ordinances of the City of Richardson not in conflict with the provisions of this ordinance shall remain in full force and effect.
- **SECTION 4.** That should any sentence, paragraph, subdivision, clause, phrase or section of this ordinance be adjudged or held to be unconstitutional, illegal or invalid, the same shall not affect the validity of this ordinance as a whole, or any part or provision thereof other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of the Comprehensive Zoning Ordinance as a whole.

## LEGAL DESCRIPTION

BEING a tract of land situated in the SARAH EACHARY SURVEY, ABSTRACT NO. 1616, Dallas County, Texas, and further being a part of LOT 27, BLOCK 1, of the Revised plat of TOWN NORTH PARK NO. 1 to the City of Richardson as filed in Volume 791, at Page 998 of the Map Records of Dallas County, Texas, and being more particularly described by metns and bounds as follows;

BEGINNING at a point in the West right-of-way line of Plano Road. (70 feet from centerline of a proposed 140 foot right-of-way), said point being North a distance of 381.39 feet along said Plano Road West line from the North line of Buckingham Road (a 100 foot right-of-way), an iron stake for corner;

THENCE West leaving the said West line of Plano Road, a distance of 165 feet to a point for corner;

THENCE South a distance of 231.39 feet to a point for corner;

THENCE North 87 degrees 47 minutes East, a distance of 15.13 feet;

THENCE South a distance of 150 feet to a point in the North rightof-way line of Buckingham Road;

THENCE South 87 degrees 47 minutes West, (618.46 feet along said North line of Buckingham Road to a point for corner;

THENCE leaving Buckingham Road and going North along the East line of a 16 foot alley a distance of 840.56 feet;

THENCE North 45 degrees East along an alley cutback line, 21.21 feet;

THENCE East, 752.88 feet along the South line of a 15 foot alley, to a point for corner in the West right-of-way line of Plano Road;

THENCE South along the West right-of-way line of Plano Road, 450.84 feet to the place of beginning and containing 13.437 acros of land.

**SECTION 5.** That any person, firm or corporation violating any of the provisions of this ordinance shall be shall be subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of the City of Richardson, as heretofore amended, and upon conviction shall be punished by a fine not to exceed the sum of Two Thousand (\$2,000.00) Dollars for each offense; and each and every day such violation shall continue shall be deemed to constitute a separate offense.

**SECTION 6.** This ordinance shall take effect immediately from and after its passage and the publication of the caption, as the law and charter in such case provides.
