 Annual Budget Letter - The Commissioners agreed upon and confirmed the final letter with minor corrections. A motion to approve with corrections was initiated by Daniel Burdette, and Pam Krause 2nd the motion. Motion was unanimously approved.

6. Directors Reports/Project Updates

- Kevin Williams resignation, by Lori Smeby let the group know that member Kevin Williams submitted his immediate resignation on April 9, 2019.
- Cotton Belt Railroad Line/Trail, by Dan Baker Dart and Transportation Mobility are scheduling public meetings for Richardson and adjoining communities.
- Duck Creek Trail, by Dan Baker easement paperwork has been submitted to property owners.
 Waiting for them to sign and give back. Texas Department of Transportation has requested an archeological survey. A consultant has come back and said it is not needed, so paperwork has been submitted, in hopes that they will waive the need for the survey.
- SCNA Portal Project, by Dan Baker the large portal stones should arrive April 29th. Work should take approximately 6 8 weeks. Continuing to work on perimeter.
- Inclusive Playground/Cottonwood, by Dan Baker surfacing is going down. Should be installed completely by end of the week. Like concrete, it needs to set up for 4 or 5 days. Rotary garden is delayed due to weather. Ribbon cutting has been announced for April 23, 2019.

- Breckinridge Park Trail work, by Dan Baker the City has bond dollars for Breckinridge trail work.
 Survey has been completed. Design to be started soon. October 2019 is the estimated project start.
- Breckinridge Small Playground Replacement, by Lori Smeby accessibility needs are going to be too
 great for the bond money that has been allotted for the project. There's a new plan to use the bond
 money and apply it to Windsor Park playground replacement. Breckinridge playground will be
 addressed at a future date.
- Photography in the Parks, by Lori Smeby recap of the observation and data collection that has been
 done out at Prairie Creek Park. In addition, there were other opportunities for "Picture Perfect"
 outreach: hosted an open house; signs were put up in various parks which have photogenic areas;
 brochures were distributed; flyers were put in water bills; posted on social media; developed a
 webpage that is dedicated to photography. 400 hours of observation, over 32 weeks. Code
 enforcement officers will continue to be out on the weekends. Council representatives are aware of
 the findings.
- Weekend Services Program, by Lori Smeby a weekend services program has been initiated. The
 program has people, in the parks, to assist with situations in the parks, or to be proactive with pavilion
 rentals, etc.
