**RESOLUTION NO. 20-03**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHARDSON, TEXAS, TERMINATING THE LOCAL STATE OF DISASTER WITHIN THE CITY RELATED TO THE DANGERS TO THE PUBLIC HEALTH, SAFETY AND WELFARE FROM THE OCTOBER 20, 2019 SEVERE WEATHER EVENT; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, by proclamation issued on the 28<sup>th</sup> day of October, 2019 the Mayor declared a local state of disaster for the City of Richardson resulting from severe weather by virtue of the authority vested in the Mayor, by the City Charter as the presiding officer of the governing body and under Government Code Section 418.108; and

**WHEREAS**, the local disaster declaration was in connection with the October 20, 2019 severe weather; thus, there were dangers present to the public health, safety, and welfare resulting therefrom; and

**WHEREAS**, the local declaration of disaster was continued in effect by the City Council which provided that the local declaration of disaster would continue in effect until terminated by the City Council; and

**WHEREAS**, the conditions necessitating the local state of disaster have ceased to exist and, accordingly, the City Council desires to end the local declaration of disaster.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RICHARDSON, TEXAS:**

**SECTION 1.** That the City Council of Richardson, Texas, hereby terminates the local state of disaster declared on October 28, 2019.

**SECTION 2.** That pursuant to §418.108(c) of the Texas Government Code, this termination of a local state of disaster shall be given prompt and general publicity.

**SECTION 3.** That the above and foregoing recitals are true and correct and are incorporated herein and made a part hereof for all purposes.

**SECTION 4.** That all provisions of the resolutions of the City of Richardson, Texas, in conflict with the provisions of this Resolution be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this Resolution shall remain in full force and effect.

**SECTION 5.** That should any word, sentence, paragraph, subdivision, clause, phrase or section of this Resolution be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said Resolution which shall remain in full force and effect.

**SECTION 6.** That this Resolution shall become effective immediately from and after its passage.
