



# 2024 Submittal Calendar: Development Plans & Plats

The following is the anticipated Development Plan & Plat Review schedule for 2024, which is subject to change. If consideration and approval by the City Plan Commission (CPC) is required, meetings are typically held on the first and third Tuesday of each month at 7:00 p.m. Filing and fee deadlines are typically 7 days prior to the CPC meeting dates.

Meeting dates listed for each development cycle indicate the first opportunity for consideration by the CPC. Actual meeting dates for an application may change due to application review, CPC agenda case volume, and continuation of public hearings.

Prior to the Initial Review, all applicants must schedule a Mandatory Review Conference with a Planner at least five (5), and no more than twenty (20), working days prior to the anticipated Initial Review by calling 972-744-4240. The required form from the planner will provide information related to the number and types of plans to be reviewed and will accompany the application.
