COUNCIL GOALS

- To have clear, effective, efficient, continuously improved, and consistently applied processes and policies that make it easy for residents, employees, and all stakeholders to interact with the City
- To have residents and all stakeholders choose Richardson as the best place to locate, contribute, and engage

Strategies

- Value, protect, and create a positive return on city, resident, and other stakeholder investments in the City
 - Tactic: Renew League of American Bicyclists' Bicycle Friendly Community status; discuss process to attain a Silver-level Bicycle Friendly designation



ATP OBJECTIVE

Create a visionary 10-year plan that connects **all active transportation** elements – bicycle, pedestrian, transit, and
micromobility – to leverage existing infrastructure and capitalize on
future transportation projects to create a network that is more **accessible and usable by all ages and abilities** in Richardson.

IMPLEMENTATION UPDATES



BICYCLE FRIENDLY COMMUNITY

 Bicycle Friendly America is a program through the League of American Bicyclists to recognize those making bicycling a real transportation and recreation option for all people



- Richardson was first awarded Bronze-level Bicycle Friendly Community (BFC) in 2015
 - First community to receive recognition in North Texas
 - Renewed in 2019 at Bronze-level
- UT-Dallas awarded Bronze-level Bicycle Friendly University in 2020
 - Seeks renewal in 2024 with goal for Silver-level



BICYCLE FRIENDLY COMMUNITY

- BFC application is reviewed by a panel of national bicycle professionals
 - No single path to enhance Bicycle Friendly designation
- Application evaluates community through five E's
 - Engineering
 - Education
 - Encouragement
 - Evaluation & Planning
 - Equity & Accessibility





BICYCLE FRIENDLY COMMUNITY

BFC renewal in 2024 will strive for Silver-level recognition

Schedule:

- Spring 2024: Prepare BFC Application
- June 2024: Application Deadline
- July-Oct 2024: BFC Public Survey
- December 2024: Awards Announced






ENGINEERING – POLICY

- Complete Streets Policy
 - ATP recommended action for FY 2023-24
 - Policy framework specifying how the community will plan, design, and maintain streets so they are safe for all users of all ages and abilities
- Bicycle Parking Regulations
 - ATP recommended action for FY 2023-24
 - Specifies required bike parking for new development to increase the availability of secure and convenient bike parking
 - CZO versus PD





ENGINEERING – NEW INFRASTRUCTURE




- 10% expansion of existing active transportation network
- Feasibility studies (led by others)
 - Duck Creek Trail extension to Garland under Jupiter/Belt Line
 - Trail connection to Plano under PGBT near Waterview (Prairie Creek)

ENGINEERING – NEW INFRASTRUCTURE

- Cotton Belt Regional Trail; 3.3 miles
 - USDOT RAISE Grant \$25M (June 2023)
 - TxDOT Transportation Alternative Grant \$25M (October 2023)
- Central Trail Extension; 1.4 miles
 - 2022 Transportation Alternative Grant
 - Partnership with Dallas County design begins in 2024
- Custer Road bike lanes (Arapaho to Campbell); 1.0 mile
 - Estimated completion January 2024
- Glenville Drive bike lanes (Arapaho to Campbell); 1.0 mile
 - Estimated completion Late-2024





ENGINEERING – BIKE SIGNALS


- Dedicated traffic signal head for bicyclists
- Federal Highway Administration (FHWA)
 - Established standards in 2013
- Traffic signal phasing adjusted to restrict vehicle turning movements across bike path
- Benefits
 - Enhanced safety and guidance for bicyclists at intersections
- Proposed: Greenville/Arapaho, Glenville/Collins





ENGINEERING – GREEN PAINT


- Green color is national standard for bike lanes
- Federal Highway Administration (FHWA)
 - Established standards in 2011
- Benefits
 - Increase driver awareness of possible presence of cyclists and where those cyclists are likely to be positioned within the road
 - Help guide cyclists across an intersection
- Piloted on Greenville Ave bike lanes in 2020
- Proposed: Custer, Greenville, Glenville





ENGINEERING – MAINTENANCE

- Bike lane marking maintenance
 - Goal for 5-year refresh cycle on bike lane markings
 - Enhanced funding \$100,000 to \$210,000
- Bike lane separation enhancement on Greenville Avenue (Arapaho Rd to Alma Rd)
 - Protection for increased safety
 - More durable material



EDUCATION & ENCOURAGEMENT



- Bike education at COR Recreation Centers
 - Bicycle Flat Tire Repair Workshop (Nov 15)
- Partnering with NCTCOG to develop a Safe Routes to School Plan
 - Support provided for one (1) school which will be template for additional future planning
- Coordinating with BikeDFW to bring League Cycling Instructor training to the area – Spring 2024
 - Key city staff will participate to expand capacity for educational events
 - Open to the public for all bike advocates



EQUITY & ACCESSIBILITY

- Addressing ADA issues on an on-going basis
- Coordinating with Network of Community Ministries
 - Distribute educational materials (bicycle/pedestrian safety, Smart Cycling guide, traffic safety coloring books, etc.)
 - Considering educational/bike repair events at Network
- Developing potential events at the Senior Center
- Working with DART on bus shelters

FORMALIZING THE COMMITTEE



WHAT IS THE BPAC?

• **Purpose**: Advise the City by providing recommendations on bicycle and pedestrian plans, policies, programs, and projects to achieve the goals of the City's Active Transportation Plan.

Role:

- Serve as a check for decisions regarding bicycles and pedestrians
- Receive presentations and opportunities for input to agency staff on major projects (e.g. ATP, Complete Streets policy, street reconstruction)
- Provide constructive guidance on bicycle and pedestrian issues
- Opportunity for residents to voice their input and receive a response



WHY FORMALIZE BPAC?

- Recommendation in the ATP
- Officially-recognized BPAC important with Bicycle Friendly application
- Key stakeholder on policy development
 - Complete Streets policy, bike parking regulations
- Existing BPAC operates as sub-committee to Parks and Recreation Commission
 - Two (2) Commissioners and five (5) citizen members with City staff representation
 - Committee has guidance on structure but not adopted bylaws
 - Membership application and appointment process undefined





BPAC MEMBERSHIP

- Committee appointed by City Council composed community members and COR technical experts
 - Five (5) resident members
 - Law enforcement (RPD)
 - Transportation engineer (Transportation & Mobility)
- Affiliate members from other agencies
 - Non-voting members but invited to represent agency interests
 - E.g. UT-Dallas, Chamber, DART, NCTCOG, RISD/PISD
- Two (2) year terms with a limit of four (4) consecutive terms
- Chair and Vice Chair positions determined by City Council

PATHWAY TO SILVER – 2024

Key Steps:

- Expand and improve bikeway network
- Adopt a Complete Streets policy
- Develop community-wide bicycle parking regulations
- Officially-recognized active BPAC
- Improve bicycle safety education for students
- Develop a comprehensive road safety plan (Vision Zero)
 - Pending grant funding request
- Increase budget and staff resources




NEXT STEPS

Tactic:

Activate disc golf course and begin programming efforts



Master Plan Recommendation

- Disc Golf Ranked 15 out of 25 top priorities in PROSMP
- Consultant recommended 3 potential locations:
 - Breckinridge Park
 - Crowley Park
 - Fox Creek Park
- Breckinridge site hosted 4 prior tournaments successfully on temporary course

Funding

- Proposal Developed
 - Spring of 2022
 - Spring of 2023 updated
- Submitted and approved in expanded FY24 budget
- Total Project Cost \$22,473
 - Includes consultant design cost of \$10,000



Aerial and Zoning Map










Proposed Concept Plan (Overall Site - Exhibit B)






Proposed Concept Plan (Phase 1) - Exhibit B



ZF 23-12 Request Summary



Applicant's Request

Amended PD Planned Development for I-M(1) Industrial District with modified development standards including an amended Concept Plan and approval of a Special Permit for manufacturing, heavy.

City Council Action

If City Council approves the request, the following conditions shall apply:

(Applicable to the PD Planned Development - Conditions 1. a.-f.)

- 1. The property shall be zoned PD Planned Development for the I-M(1) Industrial District and Phase 1 shall be developed in conformance with the Concept Plan (Exhibit "B") and Building Elevations (Exhibits "C-1" through "C-3"), and in accordance with the requirements of the I-M(1) Industrial District zoning regulations, except as otherwise provided herein:
 - a. Maximum Building Height: Forty (40) feet shall be permitted for a single-story building, said height to include the parapet wall. (new condition)
 - b. Parking for Manufacturing use: One (1) space per 1,000 square feet. (carried-over)
 - c. Parking for Office use: One (1) space per 300 square feet. (carried-over)
 - d. Sidewalk: The sidewalk adjacent to Research Drive and Telecom Parkway for Phases 1 and 2 shall be completed in its entirety as a part of the first phase of development. (carried-over)

ZF 23-12 Request Summary



- e. Loading Dock Screening: A 10-foot-tall concrete screening wall shall be constructed adjacent to the loading docks shall be constructed in conformance with Exhibit "B". Additionally, a landscape screen shall be provided along the screening walls and along the eastern property line in conformance with Exhibit "B". (new condition)
- f. Development of Phase 2 (Future Development Tract on Exhibit "B") shall incorporate similar screening elements for loading dock areas as required in Condition 1.e. above. (new condition)

(Applicable to the Special Permit – Conditions 2. a. & b.)

- 2. A Special Permit shall be granted for a "Manufacturing Facility, Heavy" use for the manufacturing of personal care products which shall be limited to the Phase 1 area shown on the Concept Plan, marked as Exhibit "B", subject to the following conditions:
 - a. No other person, company, business or legal entity may operate a "Manufacturing Facility, Heavy" use on the property other than Naturich Labs Incorporated. The Special Permit automatically terminates upon the change in ownership or operator, in accordance with Article XXII-A, Section 7 of the Comprehensive Zoning Ordinance, as amended.
 - b. A building permit shall be obtained from the city in accordance with Article XXII-A, Section 7.(b.) of the Comprehensive Zoning Ordinance, as amended.
