#### **RESOLUTION NO. 12-08**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHARDSON, TEXAS, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN ECONOMIC DEVELOPMENT AGREEMENT PURSUANT TO CHAPTER 380, TEXAS LOCAL GOVERNMENT CODE, BY AND BETWEEN THE CITY OF RICHARDSON AND HARTMAN RICHARDSON HEIGHTS PROPERTIES, LLC, A TEXAS LIMITED LIABILITY COMPANY (HEREIN THE "COMPANY"); PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** the Company is the owner of the Richardson Heights Shopping Center located at the southwest corner of Main Street/Belt Line Road and North Central Expressway & US 75 in Richardson, Texas (the "Center"); and

WHEREAS, the Company intends to renovate the improvements in the Center located at 100 S. Central Expressway, Suite 14, Richardson, Texas (the "Improvements"), and has or intends to enter into a lease (the "Lease") of the Improvements following the renovation thereof (the "Leased Premises") for a period of at least fifteen (15) years with the Alamo Drafthouse Cinemas, LLC, a Texas limited liability company (the "Lessee"), for the operation of an Alamo Drafthouse Cinema and Restaurant (collectively the "Theater"); and

**WHEREAS,** the Company intends to invest approximately Four Million Eight Hundred Thousand Dollars (\$4,800,000.00) in the renovation of the Improvements for the occupancy of the Leased Premises by the Lessee; and

**WHEREAS,** the Company has advised the City that a contributing factor that would induce Company to renovate the Improvements and enter into the Lease would be an agreement by the City to provide an economic development grant to the Company to defray a portion of the costs of the renovation of the Improvements for the Lessee; and

**WHEREAS,** the City has adopted programs for promoting economic development, and this Agreement and the economic development incentives set forth herein are given and provided by the City pursuant to and in accordance with those programs; and

**WHEREAS,** the City is authorized by Article III, Section 52-a of the Texas Constitution and Texas Local Government Code Chapter 380 to provide economic development grants to promote local economic development and to stimulate business and commercial activity in the City; and

**WHEREAS,** the City has determined that making an economic development grant to Company in accordance with this Agreement is in accordance with the City Economic Development Program and will: (i) further the objectives of the City; (ii) benefit the City and the City's inhabitants; and (iii) will promote local economic development and stimulate business and commercial activity in the City; and

**WHEREAS,** City desires to authorize the City Manager to negotiate and enter into an Economic Development Agreement with Company pursuant to Chapter 380 of the Texas Local Government Code.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RICHARDSON, TEXAS:

SECTION 1. That the City Manager, or designee, is hereby authorized to negotiate and execute one or more Economic Development Agreements pursuant to Chapter 380 of the Texas Local Government Code (and any amendments thereto, including any related instruments), on behalf of the City of Richardson, Texas, with Hartman Richardson Heights Properties, LLC (and its affiliated and related entities), in accordance with the following criteria: (a) contingent on the Company renovation of the Improvements and entering into the Lease of the Improvements with the Lessee Theater; and (b) the City shall provide ten (10) Annual Sales Tax Grants, each equal to one hundred percent (100%) of the sales tax receipts from the sale of taxable items by the Theater, provided the Lessee continuously leases, occupies and operates Theater open to the public, and five (5) Annual Grant(s) each in the approximate amount of \$300,000.00 in the total aggregate amount not to exceed a negotiated Maximum Annual Grant Amount.

**SECTION 2.** That all provisions of the resolutions of the City of Richardson, Texas, in conflict with the provisions of this Resolution be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this Resolution shall remain in full force and effect.

**SECTION 3.** That should any word, sentence, paragraph, subdivision, clause, phrase or section of this Resolution be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said Resolution which shall remain in full force and effect.

**SECTION 4.** That this Resolution shall become effective immediately from and after its passage.
