Background Information: The 2021 Bond Program included the renovation of the City

Hall. Staff hired the team of Architexas and Steinberg Hart to design the renovation improvements and prepare plans and specifications. In August of 2022, a fire damaged the building and in May 2023 voters approved constructing a new City Hall instead of renovating the existing, fire

damaged building. Following two rounds of public outreach and updated space programming needs, the design team

has provided a schematic design for review and consideration that is responsive to the program

requirements and public input. Staff will review the key elements of the schematic design and seek input from the

Council to include in subsequent design updates.

Background Information: The 2021 Bond Program included the renovation of the

Richardson Public Library. Staff hired the team of Architexas and Steinberg Hart to design the renovation improvements and prepare plans and specifications.

Balfour Beatty Construction was selected in June of 2023 to be the Construction Manager at Risk for the project and has been providing pre-construction services that include cost estimating, constructability reviews and scheduling. Balfour Beatty competitively bid the proposed plans in December and now has a proposed Guaranteed Maximum Price (GMP) of \$31,422,783 to construct the proposed

improvements. Staff will review the key project elements, budget and schedule and recommend approval of the proposed GMP on the February 12, 2024 Consent Agenda.
