Summary

Staff will review newly developed standard construction details that more clearly define expectations regarding tree protection for contractors working in the right-of-way, on city property, or on other city infrastructure. Additionally, proposed tree protection and mitigation requirements will be presented for City Council consideration in anticipation of adoption at a future meeting. Finally, Staff will provide an overview of the Tree City USA certification and requirements.

City Council Strategies

 Value, protect, and create a positive return on city, resident, and other stakeholder investments in the City

Background

As part of the Work Plan for the 2023-2025 term, the City Council adopted a tactic to develop construction standards and policies aimed at protecting trees and reducing the impact of construction projects on existing trees. Staff subsequently conducted an evaluation of existing standards and surveyed requirements adopted by Richardson's comparator cities. As a result, Staff recently implemented new standard construction details to provide additional guidance to contractors regarding trees. Staff will also be presenting potential new ordinance requirements for commercial property that will encourage the protection of existing trees by establishing mitigation requirements when trees are removed. Staff's proposals are in line with comparator cities and aim to strike a balance that emphasize preservation of existing trees without discouraging economic development.

Financial Considerations

A component of the proposed requirements will establish a fee in lieu of mitigation that would allow property owners to pay a fee rather than replace trees on-site. This fee could be dedicated to fund future tree and landscape enhancements around the City.
