Summary

Cultural Arts Commission Vice Chair Elizabeth Gonzalez will present the Commission's recommendations to council for the recipients of the FY24 Cultural Arts Initiative Grant program.

City Council Strategies

- Continue to explore unique opportunities to attract and retain residents and all stakeholders
- Value, protect, and create a positive return on city, resident, and other stakeholder investments in the City

Background

The Cultural Arts Initiative Grant program is funded from the remainder of the annual Cultural Arts Grant program, with \$26,500 reserved for this initiative in FY24. The grant program is aimed to partially fund new cultural initiatives that are not part of an organization's traditional season or offerings, with special consideration given to:

- A special performance or series that provides a unique cultural or artistic offering to the community
- A performance or exhibit that integrates technology and/or interactive components
- A collaborative art project between multiple organizations
- An additional community outreach initiative that provides enrichment to Richardson residents

The funding may also be considered for equipment relevant to the artists or professional aspect of the organization.

The Cultural Arts Commission received nine total applications. Four of the applications were determined to meet the criteria of the grant program and were interviewed by the commission members. Following the interviews and deliberation, the Cultural Arts Commission recommends awarding the funds as outlined below.
