1. Chairman Bill Chance called the meeting to order at 6:00 p.m.

2. Approval of Minutes

a. May 9, 2024 - Member Martin made a motion to approve the minutes and Member Hard-Wilson seconded the motion. The meeting minutes were unanimously approved.

3. Presentations

- a. Open Meetings Act Training Aimee Nemer, City Secretary presented the Texas Open Meeting Act. She also gave an overview of the requirements for board members. The Texas Open Meetings Act was established to make sure elected officials understand what they are voting on and when they will be meeting so they can have input on those discussions. The public must know what is discussed in our meetings and what was voted on.
- b. Bicycle Friendly Community Application & Survey Daniel Herrig indicated that the application was submitted at the end of June. Next step is a national panel of experts will review the application. Next week the public will be able to complete a Bike Survey online and will be available for 3 months.
- c. Complete Streets & Performance Measures Michael Deasy shared what progress has been made so far in adopting the Complete Streets Policy. Mr. Deasy outlined a framework for developing performance measures to facilitate tracking progress on implementing the Active Transportation Plan and Complete Streets Policy. City staff will be developing draft performance measures for BPAC to review.
- d. Programmed Projects to Improve US 75 Bike/Ped Crossings Daniel Herrig showed maps of existing bike/pedestrian crossings and additional funded projects to improve connections across US 75. He reviewed the phases and general scope of the work to be done for each project.

 - a. Adoption of Complete Streets Policy & Bike Parking Ordinance The Complete Streets Policy was adopted by City Council on June 3, 2024. The Bike Parking Ordinance was adopted by City Council on June 3, 2024.
 - b. Southwest Richardson Bike Lanes Mr. Herrig provided a status on the progress of bike lanes in the area between Coit and Floyd and Beltline and Spring Valley. Phase 2 was delayed due to the Memorial Day storm.
 - c. Safe Routes to School (SRTS) Plan The City is partnering and coordinating with NCTCOG & RISD schools to collect data and identify issues for school traffic circulation at Dover Elementary. Observations will also be conducted in late August and September. The plan is to have a draft report by the end of the school year.
