- Leverage county, state and federal opportunities




REMINDERS FROM THE 2021 REDISTRICTING





 - Testimony in person (if permitted)
 - Letters and e-mails
 - Phone Calls and meetings
 - Richardson Legislative Day





HIGHEST LEGISLATIVE AGENDA PRIORITY

- Preserve the ability for locally elected officials to govern and respond effectively and efficiently to the individual and market driven needs of its residents, and other stakeholders
- Oppose any legislative action that would erode home rule authority of municipalities or establish unfunded mandates that constrain the ability of cities to allocate scarce resources to locally determined priorities
- Support legislation seeking to restore local control/home rule authority eroded by prior legislation
- Support legislation that blocks any attempts to prohibit the authority of the City Council to
 use public funds to communicate with legislators and state agencies as well as pay
 membership dues to organizations that hire lobbyists
