Summary: During the 2011 Special Legislative Session, the Texas

Legislature made changes to the Goods-in-Transit (GIT) exemption that is granted by the Tax Code. The GIT exemption applies to inventory that is shipped inside or outside the state within 175 days if the goods are held in a warehouse not owned by the owner of the goods. The GIT exemption is automatic unless the governing body holds a public hearing and adopts an ordinance that specifically taxes the property on or after October 1, 2011 and before January 1, 2012. If no action is taken

the exemption is automatic.
